EMERGENCY PROCEDURES

24 HOUR ADVICE IN AN EMERGENCY ONLY 0800 243 622

IF THIS HAPPENS DO THIS

Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services: Dial 111
Spill or leak	Use appropriate protective equipment. Clear area of unnecessary personnel. Spills should be cleaned up immediately mechanically. Large Spill: Contain and recover as much as possible to a salvage container. Do not allow product or run-off to enter waterways or drains.
Fire	Call the Fire Service: Dial 111. Self-contained breathing apparatus required. Smoke may be toxic. Do not allow contaminated run-off to enter drains.

FIRST AID

24 HOUR ADVICE IN A FIRST AID EMERGENCY 0800 POISON (0800 764 766)

If Swallowed:	Do NOT induce vomiting. Rinse mouth. Contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor for advice if you feel unwell.
If in Eyes:	Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing for at least 15 minutes. Get medical attention if irritation persists.
If on Skin:	If skin contact occurs, remove contaminated clothing and wash skin with soap and water. If irritation persists, get medical attention.
If Inhaled:	Move person to fresh air immediately and keep at rest in a position comfortable for breathing. Get medical advice if person feels unwell.

STORAGE AND SEGREGATION SUMMARY

Storage: Store securely in original container, tightly closed and in a dry, cool, well ventilated area away from foodstuffs.
