EMERGENCY PROCEDURES

24 HOUR ADVICE IN AN EMERGENCY ONLY 0800 243 622

IF THIS HAPPENS DO THIS

Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services: Dial 111
Spill or leak	Use appropriate protective equipment. Clear area of unnecessary personnel. Spills should be cleaned up immediately. Large Spill: Contain and recover as much as possible to a salvage container. Do not allow product or run-off to enter waterways or drains.
Fire	Call the Fire Service: Dial 111. Self-contained breathing apparatus required. Smoke may be toxic. Do not allow contaminated run-off to enter drains.

FIRST AID

24 HOUR ADVICE IN A FIRST AID EMERGENCY 0800 POISON (0800 764 766)

If Swallowed:	Do NOT induce vomiting. Contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor for advice if you feel unwell.
If in Eyes:	Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Get medical attention if irritation persists.
If on Skin:	If skin contact occurs, remove contaminated clothing and wash skin with soap and water. If irritation persists, get medical attention.
If Inhaled:	Move person to fresh air immediately and keep at rest in a position comfortable for breathing. Get medical advice if person feels unwell.

STORAGE AND SEGREGATION SUMMARY

Storage: Store securely in original container, tightly closed and in a dry, cool, well ventilated area away from foodstuffs.
