Spills should be cleaned up immediately mechanically. Large Spill: Contain and recover as much as possible to a salvage container. Do not allow product or run-off to enter waterways or drains. Call the Fire Service: Dial 111. Self-contained breathing apparatus required. Smoke may be toxic. Remove contact lenses, if present and easy to do. Continue rinsing for at least 15 minutes. Get medical attention if irritation persists. If Inhaled: Move person to fresh air immediately and keep at rest in a position comfortable for breathing. Get medical advice if person feels unwell.
