| IF THIS HAPPENS                | DO THIS  |
|--------------------------------|--|
| <b>Tanker/Vehicle Accident</b> | Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks.<br><b>Call the emergency services: Dial 111</b>   |
| <b>Spill or leak</b>           | Use appropriate protective equipment. Spills may be slippery and should be cleaned up immediately. Pump as much as possible into a salvage container. Absorb the remaining liquid and any small spills with clay granules, sand, or other absorbent material and sweep into a waste container. Minimise run-off into drains or waterways |
| <b>Fire</b>                    | <b>Call the Fire Service: Dial 111.</b><br>Vapours may be toxic. Self-contained breathing apparatus required, chemical suit recommended. Addition of water may cause excessive foaming. Do not allow contaminated run-off to enter drains or waterways.  |

| <b>If Swallowed:</b> | Immediately call a Poison Centre or doctor. Rinse mouth with water. Do NOT induce vomiting. Get medical advice.   |
| <b>If in Eyes:</b>   | Hold eyelids apart and rinse the eye cautiously for at least 15 minutes. Remove contact lenses, if present and easy to do, continue rinsing. Contact a Poisons Centre or doctor for advice. |
| <b>If on Skin:</b>   | Immediately take off contaminated clothing and flush skin and hair with running water. Continue for at least 15 minutes. Get medical attention if irritation or rash occurs.                |
| <b>If Inhaled:</b>   | Remove patient to fresh air and keep at rest in a position comfortable for breathing. If experiencing respiratory symptoms contact a Poisons Centre or doctor immediately.                  |
